Debit Card Technology

Trust Administrators' RepayMe Card is a "stored-value" Card, more commonly known as a "debit" card. The Card is used by employees to pay transit and parking expenses in connection with an Employer's Commuter Benefit Plan (I.R.C. section 132(f)). The Card works at transit agencies and parking facilities throughout the country where VISA® is accepted.

The Card is the first "Nationwide" commuter debit card. The Card works in San Francisco, Washington, D.C., New York, Chicago, Philadelphia and Boston.

No more employer hassles with different voucher providers from every city because the Card works everywhere - it's a faster and more efficient way to administer commuter benefits.

Implementing A Debit Card Commuter Plan

Implementing a Commuter Plan with Debit Card technology is simple. Trust Administrators, Inc. (TAI) provides employee materials, toll-free "Advice Line" and ongoing payroll interface. If you're using vouchers, it's easy to switch.

Employees sign up for pre-tax contributions either online or traditional paper enrollment. The Card is mailed to employees' homes and funded each pay period. Next, employees begin "swiping" the Card to pay their commuting expenses. Since payment is electronic, there are no claims to file. TAI monitors all transactions for compliance.

Employers of any size, from every industry (public, private and non-profit) can implement a Debit Card Commuter Plan.

Commuter Plan Tax Savings and Features

EMPLOYEES: Under federal law, The Plan allows employees to contribute pre-tax salary up to \$105 per month for mass transit expenses (buses, ferries, trains, vanpools) and up to \$205 for parking expenses (not gasoline or tolls) for calendar year 2006. Because contributions are pre-tax, employees save 30% to 50%, based on their federal and state income tax brackets.

Check reimbursement, direct deposit and payroll reimbursement if VISA® location unavailable.

EMPLOYERS: Employers share in the tax savings with lower contributions to FICA and workers' compensation - a tax savings from 8% to 10% for each dollar contributed by employees.

- Debit Card issued for plan year not monthly vouchers
- No Tax Form 5500 required under I.R.C. Section 132(f)

The Debit Card is a national commuter program under I.R.C. section 132(f) offered by Trust Administrators, Inc. ("TAI"). TAI provides administrative services supporting public and private efforts to reduce traffic congestion, improve air quality and promote public transportation and carpooling. TAI's Debit Card also works with an Employer's Cafeteria Plan enabling employees to pay doctors, dentists, pharmacy, vision and dependent day care expenses up to \$5,000 per calendar year creating one integrated pre-tax benefits package.
